## **-ACCEPTABLE PHOTO IDS FOR VOTING IN WISCONSIN-**

*Information Provided by the State of Wisconsin Government Accountability Board*

### **DO I NEED A SPECIAL VOTER ID CARD?**

There is not a separate "Voter ID" card. There are many forms of photo ID, which you may already have, that can be used to vote. Anyone with a valid Wisconsin driver license or Wisconsin state ID card, or any of the documents listed below, already has the photo ID they need for voting purposes.

### **WHAT CAN I USE AS PHOTO ID TO VOTE?**

The following photo IDs are acceptable for voting purposes, and can be unexpired or expired after the date of the most recent general election (currently, the November 4, 2014 election):

- A State of Wisconsin Driver License, even if driving privileges are revoked or suspended
- A State of Wisconsin Identification Card (ID)
- Military ID card issued by the U.S. Uniformed Services
- A U.S. passport book or card

The following photo IDs are also acceptable for voting purposes:

- A certificate of naturalization (that was issued no earlier than two years prior to the election)
- An identification card issued by a federally recognized Indian tribe in Wisconsin
- A driver license or state ID card receipt issued by Wisconsin DOT (valid for 45 days)
- A photo identification card issued by a Wisconsin accredited university, college, or technical college that contains the following:
  - Date the card was issued
  - Signature of student
  - Expiration date no later than two years after date of issuance
  - The university or college ID must be accompanied by a separate document that proves enrollment, such as a tuition fee receipt, enrollment verification letter, or class schedule

### **WHAT WILL THE POLL WORKER BE LOOKING AT ON MY PHOTO ID?**

- **Elector's Photograph**  
The photograph must reasonably resemble the elector
- **Elector's Name**  
The elector's name must conform to the name on their voter registration; conform does not mean that the name must be identical to the name on the voter registration
- **Expiration Date**  
If the ID has an expiration date, it must meet the expiration requirements listed above

**An acceptable photo ID for voting does NOT have to include a current address.**

## **Condolences**

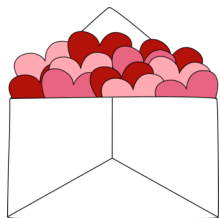

**2015: A YEAR IN REVIEW—Mary Ann Gronquist and Sue Hendrickson**

**FEBRUARY**—Radio Shack expert presented “Having Trouble with Technology?” 25 participants including several non-members. Lots of questions answered about a lot of different devices.

**MARCH**—Nearly a dozen members did “On the Move and in the Groove”. Members and others assembled children’s quilts at annual Quiltathon at local mall. 132 distributed to Twin Ports organizations serving kids in crisis. Materials donated; batting purchased with proceeds from annual quilt raffle.

**APRIL**—30 crafters (including members from Douglas and Bayfield counties, as well as several non-members) chose from 9 classes at annual Craft Day. Cultural Arts contest had 17 entries; nine took first at the state contest and 2 seconds.

**MAY**—Members and others attended presentation on edible ornamentals at Wentworth Greenhouse. Owner also answered many other gardening questions.

**AUGUST**—Public relations display set up at county fair. Children’s quilts were worked on, and raffle tickets sold to support Quiltathon.

**SEPTEMBER**—Representatives attended state conference; brought ideas back for program planning and Wisconsin Bookworms™. (We have 6 HCE readers and supply books to all Headstart in Douglas County.) “Building Sustainable Communities” presented at school forest by Douglas County Recycling and Extension Ag specialists included tour by the school forest manager.

**OCTOBER**—Table rentals at capacity for annual Craft Sale at county fairgrounds. Better than average turnout resulted in huge collection of food and hygiene items for local men’s mission. Door, lunch and bake sale receipts fund college and tech school scholarships.

**NOVEMBER**— “Liven-up Your Leftovers” presented at annual meeting; 62-year member Jessie Westman was honored.

**DECEMBER**—County-wide holiday dinner, fundraiser for gift cards for low-income seniors, included entertainment, prizes and food basket collection; held at local supper club.

**INTERNATIONAL**—Studying India; informational articles in newsletter monthly. Donations collected for Nicaragua delivered to Steven’s Point periodically independent member.

### **Douglas County is looking for volunteers!**

Douglas County is looking for volunteers to serve on a steering committee to guide the county in revising its Farmland Preservation Plan. The revised Farmland Preservation Plan will guide the county in making decisions about future land-use, resource management, and investments that affect the agricultural base in the county. The steering committee would meet approximately once per month for ten months (January through October 2016 ) working together with a consultant, other stakeholder volunteers, county board supervisors, county staff, and agency staff. Douglas County wants to include a diversity of perspectives and is seeking a volunteer (s) from the homemaker’s group to include the perspective of women working from home on their farm.
