

## APPLICATION PROCESS

- Applications and 3 references are due by **May 18, 2018**
- One reference form should be filled in by a parent/guardian and the others by adults from the applicant's community and school
- Forms may be picked up at the Extension office, county high schools or downloaded from the website:

- All forms need to be signed and mailed to the UW - Extension office.
- Interviews will be conducted May 21- June 8, 2018 and final selections made by June 15th.
- Orientation and training will be at the courthouse in late August or early September.
- Terms start in September 2018 and run year-round until August 2020.


### Douglas County Board of Supervisors
